ALMOSTHADITE - refers to a specimen of which the major portion remains on public display in a remote quarry.

CANTQUITESPELLITE - resembles a specimen in the University collection with an even longer and more complex name.

CANTREMEMBERITE - one of the more common specimens typically from localities generally unknown at the present time.

ONCEHADITE - Used in reference to extremely unusual specimens traded at rock shows before the true identity was realized.

USEDTOHAVEITE - a secondary form of specimens including marcasite, best recognized by the permanent brown ring where the specimen formerly sat on the shelf.

#### THANKSGIVING TRIP





### THE SEARCHERS GEM AND MINERAL SOCIETY, INC.

A Non-Profit Corporation

#### BY-LAWS

#### ARTICLE I

#### NAME AND PURPOSE

- Section 1 The name of the Corporation shall be THE SEARCHERS GEM AND MINERAL SOCIETY, INC.
- Section 2 This Society was formed for the purpose of banding together a group of congenial persons for the purpose of studying mineralogy and the earth sciences by means of association with other mineralogical societies and with their members; presentation of public exhibitions, lectures, and similar programs; field trips for exploration, study and collecting of specimens; the encouragement of interest among young people and the fostering of interest in mineralogy and the lapidary arts; the procurement and maintenance of collections of minerals, mineral products and related pictures, writings and other information thereof; and all other means which are appropriate to the accomplishment of the primary objects above set forth.

This organization is not formed for profit and none of its assets shall be used for the pecuniary gain or profit of any individual who is or may become a member thereof.

#### ARTICLE II

#### LOCATION

Section 1 - The principal office of the Corporation in the State of California shall be located in the city of Anaheim, County of Orange.

#### ARTICLE III

#### **MEMBERSHIP**

Section 1 - CLASSES OF MEMBERSHIP AND DUES. The Corporation shall have two classes of members. The designation of such classes and the

qualifications and rights of the members of such classes shall be as follows: (a) Members and (b) Junior Members. Members shall be adult the age of 17 (seventeen) and over and shall pay dues of \$10.00 (Ten Dellars) per each calendar year. Junior Members are those under the age of 17 (seventeen) years who are sponsored by an adult who is a member of this organization and the dues for such Junior Member shall be \$2.00 (Two Dellars) per calendar year, or any part thereof. The amount of dues for the next calendar year may be reviewed annually by the Directors and any suggested changes will be brought to the general membership for approval at the annual meeting in November. Approval by a simple majority of members present is required for any change.

Dues are due and payable on the first day of January each year and shall not be pro-rated. When any member in any class shall be in default for two months or by March 1st, his membership shall be terminated.

- Section 1a MILITARY SERVICE. Any member who enters the United States Armed Services shall be considered a paid up member during his tour of duty.

  Any dues paid by that individual for the current year shall be reimbursed. March 1972
- Section 2 VOTING RIGHTS Each Member shall be entitled to one vote on each matter submitted to a vote of the members. There shall be no election by mail or proxy votes.
- Section 3 EXPULSION The Board of Directors, by affirmative vote of two-thirds of all the members of the Board, may suspend or expel any member for cause after an appropriate hearing, and by a majority of those present at any regularly constituted meeting, an affirmative vote of two-thirds (2/3) of all the members of the Board and a majority of those present at any regularly constituted meeting.

#### ARTICLE IV

#### ANNUAL MEETING

- Section 1 ANNUAL MEETING. An annual meeting of the members shall be held enthe third Thursday—in the month of November each year at the hour of 7:30 P.M. for the purpose of electing Directors and for the transaction of such other business as may come before the meeting. Election shall be by ballot. There shall be an election committee appointed by the President, consisting of three members, to distribute the ballots and count the votes. Where there is only one candidate for each office, election may be made by voice if it seems desirable to dispense with a ballot vote.
- Section 2 PLACE OF MEETING. The Board of Directors may designate any place

within the County of Orange, State of California, as the place of meeting for any Annual Meeting or for any special meeting deemed necessary. Whenever possible, at least one monthly Society Field Trip will be held.

QUORUM. The members holding 33 (thirty-three) percent of the votes which may be the case at any meeting shall constitute a quorum at such meeting. If a quorum is not present at any meeting of members, a Section 3 majority of the members present may adjourn the meeting from time to time without further notice. A quorum shall consist of thirty-three percent (33%) of the membership.

#### ARTICLE V

### BOARD OF DIRECTORS

- GENERAL POWERS. The routine affairs of the Corporation shall be managed by the Board of Directors. Directors need not be residents of Section 1 -Orange County.
- NUMBER, TENURE AND QUALIFICATIONS. The number of Directors shall be seven. Each Director shall hold office until the next annual meeting Section 2 of members and until his successor shall have been elected and qualified. Each term of office shall be for one year. Directors may be elected for more than one term. Directors must be members of the corporation.
- REGULAR MEETINGS. A regular meeting of the Board of Directors shall Section 3 be held once <del>monthly</del> a month.
- SPECIAL MEETINGS. Special Meetings of the Board of Directors may be Section 4 called by or at the request of the President.
- QUORUM. A majority of the Board of Directors shall constitute a quorum Section 5 for the transaction of business at any meeting of the Board.
- COMPENSATION. Directors as such shall not receive any stated salaries Section 6 or fees for their services. Any routine expenses incurred on behalf of the Corporation shall be reimbursed.

### ARTICLE VI

OFFICERS. The officers of the Corporation shall be a President, a First Section 1 -

Vice-President (Program Chairman), a Second Vice-President (Field Trip Chairman), a Secretary, a Treasurer, and a California Federation Delegate. The immediate Past President shall remain a member of the Board, with a vote, and become an advisor thereto. These Officers shall constitute the Board of Directors. The Board of Directors shall have full authority to conduct the routine business of the Corporation.

- Section 2 -ELECTION AND TERM OF OFFICE. The officers of the Corporation shall be elected annually by the members at the regular scheduled November Annual Meeting. Installation of the elected officers shall be held at the
- Section 3 -VACANCIES. A vacancy in any office because of death, resignation, removal, disqualification or otherwise may be filled by appointment protem of the President or by election as the membership may direct.
- Section 4 -PRESIDENT. The President shall be the principal executive officer of the Corporation and shall in general supervise and control all the business and affairs of the Corporation. The President shall preside at all meeting of the Board of Directors. The President shall sign, with the Secretary or any other proper officer of the Corporation authorized by the Board of Directors, any deeds, mortgages, bonds, contracts or any other instrument which the Board of Directors have authorized to be executed. An exception will be made in cases where the signing and execution thereof shall be expressly delegated by the Board of Directors or these By-laws or by Statute to some other officer or agent of the Corporation. In general, the President shall perform all the duties incident to the office of President and such other duties as may be prescribed by the Board of Directors-from time-to-time. The President shall appoint a nominating committee. The President shall serve as an ex-officio member of each committee except the nominating committee.
- Section 5 -VICE PRESIDENT - Both Offices. In the absence of the President or in the event of the President's refusal or inability to act, the First Vice President(Program Chairman) shall perform the duties of the President, and when so acting, shall have all the powers of and be subject to all restrictions upon the President. Either Vice President shall perform such other duties as from time to time may be assigned by the President or by the Board of Directors. The Second Vice President shall serve in the absence of the President and First Vice President and shall act as Field Trip Chairman.
- TREASURER. The Treasurer shall have charge and custody of and be responsible for all funds and securities of the Corporation. The Section 6 -Treasurer Will receive and give receipts for monies due and payable to the Corporation from any source whatsoever, and deposit all such monies in the name of the Corporation in such banks as designated by the Board of Directors. The Treasurer will perform all the duties incident to the office of Treasurer and such other duties as from time to time may be assigned by the President or the Board of Directors. SECRETARY. The Secretary shall keep the minutes of the meetings of the

members and of the Board of Directors in one or more books provided for that purpose. The Secretary will see that all notices are duly given in accordance with the provisions of these By-laws or as required by law. The Treasurer will be custodian of the Corporate records and of the Seal of the Corporation and see that the Seal of the Corporation is affixed to all appropriate documents. The Secretary shall keep a register of the post office address of each member which shall be furnished to the Secretary by the Membership Chairman, and in general perform all duties as from time to time may be assigned by the President or by the Board of Directors.

Section 8 - CALIFORNIA FEDERATION DELEGATE. The CFMS Delegate shall be the representative of the Corporation to the CFMS meetings and shall provide the necessary coordination between this Corporation and CFMS; provide this Corporation with reports (verbal and otherwise) of CFMS activities. The Delegate may appoint, with the Board's approval, an alternate to act in the Delegate's absence at CFMS meetings.

#### ARTICLE VII

#### NOMINATING COMMITTEE

- Section 1 SELECTION. By the month of September, the President shall appoint a Nominating Committee of three members in good standing to select candidates for offices. The announcement shall be made at the September meeting. The Nominating Committee shall present its selections at the October meeting, at which time further nominations from the floor shall be in order.
- Section 2 ELECTIONS. Election of officers shall be held at the November meeting, at which time nominations from the floor shall be in order. Installation of officers shall be held at the December meeting.

#### ARTICLE VIII

## CONTRACTS, CHECKS, DEPOSITS, FUNDS AND DISSOLUTION OF PROPERTY

Section 1 - CONTRACTS. The Board of Directors may authorize any efficer person, agent or agents of the Corporation, in addition to the officers so authorized by these By-laws, to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation. Such authority may be general or confined to specific instances.

- Section 2 CHECKS, DRAFTS, ETC. All checks, drafts or orders for payment of money, notes, or other evidence of indebtedness issued in the name of the Corporation shall be signed by any two of the following three officers: President, Treasurer, Secretary.
- Section 3 GIFTS. The Board of Directors may accept, on behalf of the Corporation any contribution, gift or bequest or device for the general purpose of the corporation.
- Section 4 DISSOLUTION. Upon dissolution of the Corporation, Corporation property assets, if any, must go to a non-profit corporation.

#### ARTICLE IX

#### **BOOKS AND RECORDS**

Section 1 - The Corporation shall keep correct and complete books and records of account—and shall keep the minutes of the proceedings of its members, Board of Directors, and Committees having any of the authority of the Board of Directors. Minutes shall be kept of the meetings of members, Board of Directors and Committees authorized by the Board of Directors. The books and records of the Treasurer shall be audited annually in December and whenever there is a change of Treasurer. All books and records of the Corporation may be inspected by any member or member's agent or attorney for any proper purpose at any reasonable time.

#### ARTICLE X

#### AMENDMENTS TO BY-LAWS

These By-laws may be altered, amended or repealed and new By-laws be adopted by a two-thirds majority of the membership, present and voting at any regular meeting. The Directors shall notify the membership at any regular meeting one month in advance wherein a revision proposal to the By-laws will be considered. Said notice to be published in the <u>Searchers Bulletin</u> and any and all proposed revisions to the By-laws shall be published in detail one month before revisions are presented to the membership.

- Section 1 These By-laws may be altered, amended or repealed or new By-laws may be adopted by a two-thirds majority of the membership present and voting at any regular meeting in accordance with the following procedures:
  - 1. The Directors shall appoint a committee to review the By-Laws.
  - 2. The membership will be asked to submit written

suggestions to the committee.

- 3. The committee will consider all suggestions and make recommendations accordingly to the Directors.
- 4. Proposed changes will be presented at a general meeting and published in the <u>Searchers Bulletin</u>.
- 5. Additional written suggestions will be considered by the committee for final presentation to the Directors.
- 6. Any significant changes will be published and distributed prior to the memberships' vote.


#### ARTICLE XI

#### **AUTHORITY**

Section 1 - <u>Roberts Rules of Order, Revised</u>, when not in conflict with these bylaws or rules adopted, shall be the authority for the procedure of this corporation.
