
Now that you know who the Nominating Committee members are you don't have to wait for them to call you, you can call one of the committee members and volunteer to run for an office.

Dear Friend:

The California Desert Coalition has successfully affected the outcome of the controversial California Desert Protection Act (S.21/H.R.518). Although environmentalists have touted an easy passage and sure win in this nine year battle, some surprising events have taken place in recent weeks. We still do not have a desert bill.

Much to the ire of some of the most powerful and influential democrats in the country - the Coalition is being heard. And loudly. Congressman Miller, Chairman of the House Natural Resources Committee, did his best to railroad the bill through his committee, expecting easy passage on the House floor. However, we were ready with sponsors for several amendments and have diluted the bill with some startling changes. The House has approved an amendment making the East Mojave a preserve rather than a national park. This allows hunting and less stringent protection for the area and has put a major crunch in the environmentalists push for their "jewel of the desert". This is a move that is abhorrent to their agenda and totally unacceptable to them. Another amendment, perhaps the most important single vote on property rights in this Congress, also passed. This prevents the federal government from devaluing property through implementation of the Endangered Species Act, then condemning it and purchasing it at the devalued price.

Since the bill passed the House, the bill's differences must be resolved in a Joint Senate and House Committee, then again be voted on by both houses of Congress. This must be completed in less than 40 congressional working days. We must not allow this to happen!

It is clear that the Coalition has made some startling headway in defeating this bill. It is crystal clear that our decision to hire the prestigious lobbying firm of Fleishman and Hillard has been our best move. They are hard hitters and will be essential in furthering our goal to KILL THE BILL.

As the saying goes, we must line up our ducks. They must be lined up for the kill in the joint committee. The two bill versions are very different and contentious. Now we must work toward having each house defend their version of the bill, and not settle on a compromise easily. We must also work with Republicans to deny Feinstein this win to deter her chances of winning her reelection. And we can do this. But only with Fleishman and Hillard.

Just as the cost of freedom is great, so is the cost of effective lobbying. The Coalition's commitment to Fleishman and Hillard is \$8,000 a month plus expenses. We will need to fund our lobbyist for three more months. Please send a generous donation today. A return envelope is enclosed for your convenience. With your help, we will defeat this bill.

The following article is from the Baker Valley News. copied from the Spotlight, Washington, D.C.: SENATOR ACCUSED OF FRAUD

Sen. Dianne Feinstein (D-Calif.) and the Sierra Club have proposed the largest land grab in the U.S. history (8 million acre) the lower 48 states, and those opposed to it are alleging the freshman senator and former San Francisco mayor is involved in financial fraud.

The energy and mineral rich California desert is their target. The excuse for talking so much land out of multiple use, (since 1980 protected by the California Desert Conservation Area - CDCA - plan) is to "protect the fragile arid desert." However, the areas included in S.21 have largely been for sale at bargain prices for more than 100 years with no takers. There is no water and these lands, unlike the fringes of the desert (like Palmdale and Palm Springs or the Colorado River where agricultural water is being converted to urban use), are protected by their very aridity and the existing CDCA Plan enforced by the U.S. Bureau of Land Management.

The desert is known to contain several rich mineral deposits of gold, silver, rare earths, borates, talc, iron and other minerals. The CDCA produces about \$1.5 billion dollars per year in new mineral wealth for the California economy and employs more than 20,000 highly paid workers.

Several pension and health insurance funds have large holdings at risk. These include AFL-CIO, Untied Steel Workers (several trusts about 8,000 to 10,000 members and 40,000 acres), California State Teachers Pension Fund (about 250,000 members and 300,000 acres) and Catellus Corporation with about 400,000 acres owned 41 percent by CAL-PERS (California Public Employees Retirement System), representing 800,000 city, county and state employees in California.

The Steel Workers health and pension assets are the mines and highly mineralized lands acquired when Kaiser Steel's Fontana, Calif. steel mill was forced into bankruptcy by overzealous environment regulations and Japanese dumping of steel in the late 1970's.

Feinstein's

Desert Bill" includes 140,000 acres of National Forest found unsuitable for wilderness by then California Sens. Alan Cranston (D) and Pete Wilson (F) in the 1983 California National Forest Wilderness Act, including 12, 500 acres of the Bighorn Mountain Wilderness in the San Bernardino national Forest that impact the AFL-CIO trust properties.

The greatest damage to union trust assets is the expansion of Joshua Tree national Park by 234,000 acres to surround their Eagle Mountain Iron Mine of three sides with national Park Wilderness. This will probably prevent the mine from ever producing again.

The 300,000 acres of Teachers Pension fund lands are the unsold state school sections that were given by the

federal government to the state more than 100 years ago. They have been for sale for 100 years and because there is no water, they are not threatened with development.

Unlike the AFL-CIO pension and health insurance funds, the State Legislature and the State Lands Commission discouraged exploration on those lands for energy and mineral resources. Their energy and mineral value is largely unknown, but it could be high as it is not uncommon that a single deposit like gold, silver, borates or rare earth could exceed several billion dollars in value. Life the AFL-CIO trusts. The Teachers Pension could also lose big under the terms of S.21.

The 400,000 acres of Catellus Corporation, owned 41 percent by CAL-PERS's 800,000 members, are the old "checker-board" railroad lands that Catellus' railroad predecessors acquired for building transcontinental railroads.

According to Dehnert Queen, a San Francisco businessman, in his criminal complaint to U.S. Attorney Michael J. Yamaguchi and Ms. Sylvia Scott of the U.S. Security and Exchange Commission, Sen. Feinstein "misrepresented facts to defraud a public corporation (CAL-PERS, Prudential), abused power and conflicts of interest to defraud State and U.S Taxpavers..."

Mr. Queen states, "In early 1993, CAL-PERS doubled its investment in Catellus to 41 percent..." It is Mr. Queens' contention "that both Senator Cranston and Senator Feinstein acted to sponsor the Desert Protection Act (S.21)...in order to preserve and protect the formal agreement that Mayor Feinstein signed with Catellus to build the Mission Bay Project in 1984, updated in 10986 and shepherded same through the City's departments and commissions. Senator Feinstein's acting to add language in the version of Senator Cranston's original bill (which grants Catellus the RIGHT TO EXCHANGE 'USELESS' PRIVATE DESERT PROPERTY FOR VALUABLE U.S. GOVERNMENT PROPERTY), where the bill, upon being enacted Congress...will generate the monetary value (approximately \$500 million) necessary to execute Catellus' large-scale development projects located throughout the Bay Area."

It is interesting to note that Feinstein's. S.21 Catellus land-exchange language was pulled from the bill before it could be debated in the Senate Energy and Natural Resources Committee or debated on the Senate floor. S21 passed the Senate by a vote of 69 to 29 last month.

Was Mr. Queen's complaint circulating in the halls of Congress then?

Last week Rep. George Miller (D-Calif.), representing the East San Francisco Bay area, pushed through his House Natural Resources Committee S.21's companion bill, HR 518, by Rep. Richard Lehman (D-Calif.). THIS bill contained the Catellus land exchange.




