HIGHLIGHTS - BOARD MEETING MINUTES - August 28, 1998:

Minutes of the July 14, 1998 Board meeting read and corrected.

Herb Beckman said he did not agree to change his method of bookkeeping for the shop when we move into the new Senior's Center. Herb will happily change the format of his workshop bookkeeping report if so directed by the Board or membership in the form of a Motion.

Concerning guidelines for Dealer Show Cancellations at the July 14th Board meeting, the motion to adopt these guidelines was made by Betty Nelson (Co-Vice President) and seconded by Audrey Nichols (Co Vice President). Motion passed, 5 Yeas and 1 Nay. Marge Jordan, Bulletin Editor, asked that the following change be made, i.e. the two Co-Vice Presidents are only entitled to one vote and only one should be designated as the voting Vice President. The Secretary was asked to check the past Minutes/records of the voting for this year to see whether or not there have been two votes cast by that office that would change any previous motions or actions. A discussion was launched concerning the previous passage of the new guidelines for future show cancellations. No action was taken.

Faye McDowell, TReasurer, asked about the progress of obtaining an Auditor to review last year's books. Faye did not feel that her office should get the Auditor. Betty Nelson agreed and volunteered to ask Marie Cole if she would ask someone from her office to conduct the Audit.

Cliff Warner had paperwork from the city of Anaheim requesting the Searchers to have some lapidary demonstrators at the Grand Opening Celebrations for the new Senior Center. Cliff said that he has asked Ben Byland, Larry Richey, Max Johnson and Floyd Neeley to represent the Club.

Cliff said that the City of Anaheim needs a Donation of \$5000.00 from all of the Arts and Cultural organizations who will benefit from the new Center. This money will help them complete work on the new facility. Several suggestions were outlined for the amount the Searchers would donate. After we had read them, George Mitchum felt that the Board should suggest to the Membership that the Searchers donate either \$300 or \$500. This was the amount that we felt was going to be donated by other organizations in the Cultural Arts. This donation would entitle the Searchers (among other "perks") an 8" x 10" Recognition Plaque.

Betty Nelson gave an up-date on our 1998 Christmas Dinner arrangements. We will have a choice of two entrees, Prime Rib (\$16.00) or Turkey (\$13.00). Marge Jordan suggested that the Club again this year, pay \$5.00 towards MEMBERS ONLY dinner. The Board will take this recommendation to the Membership.

George Mitchum suggested that in addition to paying for the Board Members Christmas dinners that the Club also pay for the Membership Chairperson and the Bulletin Editor. These two jobs are demanding and time consuming and both Milly and Marge work hard with very little recognition. WULFENITE

Wulfenite - A subtranslucent or Transparent mineral consisting of lead molybate, PbMoO4, and crystallizing in the tetragonal system. It was named in honor of the Austrian botanist and mineralogist Franz Xaver Von Wulfen. It has a hardness of 2.75 to 3 and a specific gravity of 6.7 to 7; it shines with a vitreous to diamond like luster. The color of the mineral ranges from yellow, orange, red and grey to white, most specimens being streaked with white. Wulfenite occurs chiefly in the oxidized portions of lead veins, together with such minerals as vanadinite and pyromorphite. The principle deposits of wulfenite are in the U.S. in Utah, Nevada, New Mexico, Arizona and Pennsylvania. The mineral is a minor source of molybdenum.



EDITOR'S NOTE.—The purpose of the below article is to call attention to the local educational value of various museums, both public and private, devoted to the earth sciences. The Western Trails Museum, a private enterprise, has rendered an outstanding service to the schools of Huntington Beach. It is hoped that similar projects maintained elsewhere will receive due recognition, for their cooperation with local educational work. Every community needs more citizens like the Speer family.

WESTERN TRAILS MUSEUM is located on state highway 39, four miles north of Huntington Beach, California, situated south of Los Angeles. The museum features earth science exhibits as well as material dealing with Indian lore and the history of the early West.

The museum is owned by Mr. and Mrs. Marion A. Speer. As a mining engineer for many years the professional work of Mr. adjoining their home to house the numerous items, and provide a place where the exhibits could be seen by the public. Glass Cases

The exhibits, featuring western material, are separated by states and housed in special illuminated glass cases. Forty-five years ago in Texas Mr. Speer found his first specimen, and in 1912 he married Mrs. Speer in Colorado, who since then has taken an active part

Speer called for considerable travel over western trails. During these years of his work he was enabled to gather together numerous exhibits of value and interest. About three years ago the Speer collection became so large that a separate building was erected in the development of the Speer collections Only last January the couple made a field trip to the desert country east of Southern California and returned home with over 200 specimens to add to the exhibits of the Western Trails Museum.

Early Western History

Mr. and Mrs. Speer are lovers of western history; those who took part in the development of this vast empire and the places where the historical facts took place. In their many travels throughout the far west, the Speers did not fail to visit every place of historical interest. Many of the once booming mining camps of the early days are now completely abandoned in ruins, or are known as the "ghost" towns of the West and perhaps boast only a few residents.

No country on earth can boast of so romantic a history as that of our West. Mining camps would spring up that would in a relatively short time produce new wealth calculated by the millions, only to wane in glory in less than a generation, and finally become a "ghost" town. Exhibits in the Western Trails Museum portray in a vivid manner the early history of the west.

In carrying on his professional work, Mr. Speer has traveled over nearly 500,000 miles of Western trails, from Canada to Mexico and from the Rocky Mountains to the Pacific Coast. Included in the collection are over 20,-000 photographs taken by Speer over a long period of years.

School of Mines

In 1904, Speer entered the Colorado School of Mines, where his first real interest in minerals started. Very few people collected minerals at that time and he tells of the many fine crystallized specimens laying around the miners' bunkhouses, or even cast out upon the dumps as waste gangue material from the prosperous mines. With the present wide public interest in minerals, it is not generally possible to obtain good material as freely as in the past.

After graduating from the Colorado School of Mines, his work took him about from place to place, but he did preserve many of the fine specimens collected in the early days of mining. These are to be seen in the Western Trails Museum.

School Children Visit

The Speer collections are arranged in a neat and systematic manner, all specimens being properly and plainly labeled, so the visitor may wander about and read the explanatory inscriptions. Metallic and other economic minerals are arranged in special cases, while in other sections are featured polished specimens of the quartz and other semi-precious minerals. No duplicate specimens are kept on exhibit. These are passed along to the local school exhibits for study and teaching

Thousands of visitors come to view the Western Trails Museum each year; the registrations book last year indicated calls of visitors from every state in the Union and a number of foreign countries. No small part of the visitors to the museum are the numerous groups of local school children and high school students. These groups are conducted

through the exhibits by Mr. and Mrs. Speer and are otherwise given special consideration. No less than 50 local collectors have received their inspiration from visits to the Speer institution.

One Man's Work

The building housing the collections, the glass cases and all other work necessary to house the exhibits was done by Mr. Speer, aided by his wife, aside from his regular occupation. The museum is their hobby and their life. The Western Trails Museum is purely a hobby. No charge is made for admission and nothing is offered for sale. Visitors who wish to add a specimen to the exhibits to aid in the educational work are welcome to do so, but there are no "strings attached" to the invitation extended by the proprietors to all visitors who may wish to call.

At present Mr. Speer is an employee of the Texas Company, but they never miss the opportunity to spend their annual vacation following the lure of the Western Trails in search of additional specimens to add to the extensive collections.
