FEDERATION DELEGATE REPORT:

The CFMS/AFMS Show/Convention meeting of the Board of Directors was held Saturday, June 30, 1990 at Ventura, CA. There were 109 clubs out of 177 represented thus a quorum was established. The agenda and standing rules were adopted. The reading of the minutes of the Nov 11, 1989 meeting (as corrected) was dispensed with. A recap of this meeting follows:

The Treasurer's report was accepted showing total liabilities and capital of \$79,979.20. Last year's show (Del Mar) returned \$8,889.00. Bob Stultz presented the 1990 show budget which was accepted and he reported that the 1990 show was in the black and that all monies received after this date would be profit.

The Museum Committee was given approval to work with the L A County Museum in acquiring the Bob Gill Benitoite necklace through fund raising. Very little action has been done by this committee since Bob Stultz spent a great deal of his time with the CFMS/AFMS Show and Convention. More will be done by the fall meeting.

The CFMS Endowment Fund received over \$700 from the floor and all the receipts from the Country Store at the CFMS/AFMS 1990 show will go into the fund.

Junior Activities - "Bancroft Junior Achievement Award and Perpetual Trophy". One perpetual trophy and one individual trophy will be awarded to the winner. The perpetual trophy will remain in custody of CFMS for display at various functions. A year and name plaque will be added each year to honor the winner. First and second runner up will be given certificates. If trophies are made available by donors they will be awarded. SHOULD THE SEARCHERS INVESTIGATE THIS?

It was announced that personal property insurance is now available to individuals the cost being \$200 deductable while located at a permanent location or, \$500 deductable while material or machines are in storage or transit. The 1991 CFMS/AFMS Show will be held at San Jose Fairgrounds, San Jose, California. The name of the show "Golden Bear Show" and the theme "On Our Way to San Jose". All activities will be on the fairgrounds and camping will be available for \$10.00 per day.

A bid was submitted by Mr Sanborn that the Clubs of Castro Valley would put on a small show at Centennial Hall, Hayward, California the latter part of August 1992.

Public Lands Advisory Committee (PLAC) - Notice was just received pertaining to S-11 moving to the markup agenda in the Senate Energy and Natural Resource Committee. This now becomes a <u>CRITICAL</u> issue for all members and friends of CFMS. Action must be taken immediately to assure an honest, balanced approach to the desert planning. As of June 24, 1990, no markup has started on the House versions (HR-780 and HR-3460).

FEDERATION DELEGATE REPORT (Cont'd):

The CFMS/AFMS Banquet was a long but enjoyable evening. The Master of Ceremonies was Ray Deardorff (former dealer in the Searcher's Annual Gem Roundup). Many awards were presented. The "Golden Bear Award" - Isabella and Bill Burns; "CFMS Education thru Sharing" - Clare and Maxine Gagnon (thru the Faceter's Guild) - for opening their home to teach faceting; and "All American Award" - Barbara Forester. Geneva Holmes, Roseville, California, won the award for new bulletin, "Roseville Rock Rollers". Also, Myron Zents of the Roseville Rock Rollers was awarded recognition for his effort in preserving the Miadu Indian Site in Roseville. Should any of you go thru Roseville, Myron would be more than happy to show you the site and their new meeting place. This was my original club. They celebrated their 30th Anniversary this past spring.

I would also like to mention that our editor worked several hours in the Bulletin Editor's Booth as did Virginia George (a Searcher and editor of the Faceter's Guild Bulletin). Both Marge and Virginia attended the Editor's Breakfast and the Workshop.

ORANGE COUNTY GEM AND MINERAL COUNCIL:

The second meeting of the Orange County Gem and Mineral Council was held June 16, 1990 at the Gem and Mineral Building, Orange County Fairgrounds.

The first order of business was the nomination and election of officers and they stand as follows:

Chairman - Todd Schowalter (Representative - Orange County Fair)

Assistant Chairman - Dick Knox (Representative - Capistrano Valley Rock and Mineral Club)

Secretary - Nancy Kramp (Representative - Santa Ana Rock and Mineral Club) other items discussed were:

- Incorporation, as opposed to being a functional organization.
- Putting out literature in Orange County to inform the public as to what clubs and organizations are available, their location, functions and an application. A committee was formed to start this publication.
- A list of lectures to be developed and sent to other clubs and organizations including schools.
- A quarterly report from each Council club outlining information and activities to be distributed to Council clubs bulletin editors to publish items of interest.
 - Council Rules and By-Laws would be worked out at the next meeting.
- Operating capital in the amount of \$10 per willing club who participates was approved by vote. An annual fee of \$10 per club was discussed.
 - Provide a service for other clubs that may be weak due to lack of membership.
 - Each club should provide its own youth activities and projects.
- Orange County Natural History Museum (OCNHM) has a Speakers Bureau. Also, a club case display area may be available on a monthly basis.
- The Faceter's Guild has extended an invitation for the Council's next meeting to be held during their 11th Annual Gem Fair at Orange County Fairgrounds, Saturday, September 29, 1990 at 10:00 AM, Building # 14. This is an open meeting for all clubs and their members who are in the Council. The meeting time and place was approved by all.
 - Possible fund raisers were discussed.
- Autonetics Club is trying to resolve a way to get outsiders into their Annual Auction and meetings.

ORANGE COUNTY GEM AND MINERAL COUNCIL (cont'd):

- Each club will be mailed a Roster, this Meeting's Minutes, a Quarterly Report Form and Receipts for \$10.00.
- Joint Workshops sponsored to benefit Council clubs in the areas of Field Trips, Society Aids, Display Cases, Show Security and many more topics.
- The OCNHM is very anxious to have support and input from the Council. Meeting rooms will be available.

This is only a summary of topics discussed at the second Council Meeting, available space did not allow an in-depth review of the meeting. Please contact me if you need more information or have comments on any of the above items. Also, I would like to invite you to attend the next meeting and get a first hand view of Council activities.

Before I close this report I would like to highlight a few of Council Chairman's thoughts (copies sent to all Council club representatives):

"I see this group as a driver for the enhancement of the lapidary hobby in Orange County.

"I think we all need to emphasize to our club members that our goals are all geared to be of service to all the clubs of the county. Each club is an independent organization run by its own members. We are only trying to provide support for each club with information that they might be able to use for the betterment of their club and its activities.

"I would also hope that we can encourage <u>each</u> club to develop a program that will in some way support the youth and young adults so we can build our club's membership with these people and continue their active participation in our hobby.

"This is very necessary as our aging membership is less able to participate in Field Trips, Shows, etc. and this in turn discourages the recruiting of new young members to be the leaders of tomorrow."

If you add these notes to the review of the first Council Meeting (May bulletin) you should have a good idea of what this Council is about.

As the Searcher's temporary representative to the Orange County Gem and Mineral Council, I recommend the Searcher membership move to fully join and participate in this Council.

HEALTH HAZARD - DIAMOND SPRAY

A warning from Dr. Leland W. Marple. Although I have just recently started to facet stones, I have read extensively in various publications on polishing stone. Nowhere have I found a citation on the incredible health hazard associated with the use of 100,000 mesh diamond compound. People who are knowledgable of aerosol technology are aware of the passage of small particles, under 1 micron, through the lungs of most animals. Inhaled diamond of 1/4 micron passes directly into the blood stream and ultimately lodges in body tissue. I believe it appropriate to caution everyone to be exceedingly careful when using diamond aerosol. Get the diamond on the lap and not in the body!

HINTS FOR BEAD STRINGERS:

After stringing beads (10mm & up) have you noticed in a few days that your thread has stretched and left space between the beads? Solution: The night before you string the heavy beads, measure off plenty of thread for the project, tie a large fish sinker ($\frac{1}{2}$ oz. to 1 oz.) to one end of the thread and hang overnight. When ready to use, having been prestretched, there's no need to worry about it stretching later.

GREETINGS TO THE SEARCHERS FROM MINNESOTA -

I skipped the month of May since we were visiting relatives all month in Kansas. I did find time for a side trip to the Great Salt Plains in northeast Oklahoma to hunt for Selenite Crystals. The crystals were just under the surface of an old salt lake. As you dug, water filled the hole and by splashing the sides the crystals were exposed. They formed around sand and had an hourglass image. Will return with samples.

Early in June we headed north into Nebraska. First stop was Minden at the Pioneer Village where they have a huge collection of old cars, tractors, farm implements, plus everything else from the past as far back as 1830. They have 26 buildings full of items preserved from the past.

Next we went to North Platte. There we visited Buffalo Bill Cody's home and farm where he put together his Wild West shows. Also, the Union Pacific railroad repair yard for locomotives and switching yard. It is the biggest switching yard in the United States with 64 tracks and expandable by another 64.

Headed further west in Nebraska to Scottsbluff. Took a side trip in the car to Fort Laramie, Wyoming. Near there we saw ruts of the Oregon Trail and Inscription Rock where many early pioneers carved their names when heading toward Oregon or California.

Heading north, still in Nebraska, we stopped by Agate Fossil Beds Monument and saw more fossilized bones. Kept going until we got to Fort Robinson near Crawford, Nebraska. I was able to work in several days of hunting rocks in the Nebraska Public Grasslands. I was looking for the elusive Fairburn Agate and settled for some Prairie Agates. Hunting in foot high grass makes it difficult to see anything. While walking a gully I scared up an antelope which startled me as much as it did him. Visited an interesting Fur Trade Museum at Chadron, Nebraska.

Still heading north we crossed into South Dakota. Stopped at Hot Springs to view an excavation of Mommeth Bones. We stayed near the Black Hills out of Rapid City. Had to see Mount Rushmore as well as the history on Borghen, the sulptor of the Monument. Went to see the Petrified Forest plus visited one of the many caverns in the area.

It wasn't far to Fairburn, South Dakota where the original agates were found. I took a day hunting there and found several for examples. Later we took a drive through the Badlands. I was able to do some more hunting near the park and found colorful agates and brown and black petrified wood. Not many people in South Dakota. It has a lot of grasslands for raising cattle and some grain farms.

Further north we went through Bismark, North Dakota and then east to Fargo on the North Dakota/Minnesota border. Seems North Dakota has more grain farms than anything else.

Have now entered Minnesota "the Land of 10,000 Lakes." With all the rains must be doubled by now. Have seen plenty of thunderstorms, rain, hail and wind. Unfortunately the heat has also arrived. Nothing like California but very humid. The mosquitoes like all the pools of water. They are having a bumper crop this year.

We don't have an exact route yet but are planning to see more of the states around the Great Lakes. Until next month...


ICE CREAM SERVED AT -- 1:00 PM
